

Margaritaville Hotel San Diego Gaslamp Quarter X Los Angeles Magazine Official Rules, Terms, and Conditions

ENTRIES: To enter online, visit www.lamag.com and complete the official online entry form. Margaritaville Hotel San Diego Gaslamp Quarter X Los Angeles Magazine Sweepstakes (Prizes listed below) begins on April 18th, 2024 at 9:00 a.m. Pacific Time, and ends on or about April 30th, 2024 at 11:59 p.m. Pacific Time. All entries must be received by April 30th, 2024 at 11:59 p.m. Pacific Time, per Los Angeles magazine's clock, which is the official timekeeper of the Sweepstakes, to be eligible. Los Angeles magazine, Margaritaville Hotel San Diego Gaslamp Quarter, and its promotional partners and its affiliates (collectively "Sponsor") are not responsible for lost, late, mutilated, postage due, damaged, stolen, or misdirected entries.
